JUDGING PROCESS

The judging for the 2020 Awards will be a two-stage process.

The first stage will use purely the quantitative elements to derive leader boards from the entries.

These leader boards will inform and populate the shortlists for each category, who will go through to the second stage of judging.

For the second stage, a panel of independent and impartial judges from investors and consultants will ensure firstly that the data is correct and will use their knowledge and the qualitative elements of the entry process to decide on the winners by category.

How the judges are chosen

REFI Europe's team of independent, external judges is selected to bring a diverse range of indepth industry expertise to the judging process. All judges are required to sign a disclaimer form to keep all submitted information and the winners confidential and are obliged to declare that they have no conflicts of interest prior to judging.

How categories are allocated to judges

Groups of judges are allocated categories, which are aligned to their specific market knowledge and avoid conflict of interest. Each group of judges have no access to the submissions or results of categories they are not involved in judging.

Submission feedback

REFI Europe do not share individual judges' scores and comments, however explanations for the winner of each category will be provided online after the event.
